Basic facts about Sweden

- Population: 10.2 million
- Density: 24,8 people/km2
- Distribution: 87 % of Swedes live in cities
- Unemployment: 6,7 %
- Average life expectancy: 84 years (women) and 80 years (men)



Levels of government

National level

- Parliament has legislative power.
- Government authorities have regulatory powers



Regional level

- 21 regions and county councils
- power of taxation
- health and social care services




- 290 municipalities



The eHealth vision for 2025




The government and Swedish Association of Local Authorities and Regions (SKL):

Areas for action within the collaboration

- Legislations Ensure quality and efficiency, and satisfy the need for protection of privacy and security.
- Standards Provide conditions to make it technically possible to exchange information while ensuring quality and security
- Semantics Enable exchange of information by using consistent terms and structures
- (Follow-Up Recently added, aims to follow-up the vision)

Swedish National Medication List

- One source for information about a patients medication treatments
- All healthcare professionals that has a need will be able to see the information
- Requires work to connect, due to changes






1177 Vårdguiden

- Journalen view your health record
- Renew medication
- Time booking
